# **Notice for Empanelment of Interpreter**

#### **Required Qualification:**

(1) Graduate from a recognized university with knowledge of language(s) like Arabic, Turkish, Pashto, Persian, Azerbaijan, Armenian, Belarusian, Bashkir, Buryat, Georgian, Kazakh, Kyrgyz, Komi, Latvian, Lithuanian, Russian, Moldovan, Tatar, Tajik, Turkmen, Uzbek, Ukrainian, Estonian etc.

(2) Ability to interpret simultaneously (orally translate) from language(s) like Arabic, Turkish, Pashto, Persian, Azerbaijani, Armenian, Belarusian, Bashkir, Buryat, Georgian, Kazakh, Kyrgyz, Komi, Latvian, Lithuanian, Russian, Moldovan, Tatar, Tajik, Turkmen, Uzbek, Ukrainian, Estonian etc. in to Hindi / English.

#### Age Limit:

Minimum age shall be 25 years (age limit can be relaxed if suitable otherwise). There is no maximum age bar, provided the person is mentally and physically in good health.

#### **Process of Empanelment:**

(1) Applicants possessing the requisite qualifications will be called for a two day Orientation Programme, where they will be briefed about the art and technique of simultaneous interpretation in the concerned language;

(2) After Orientation, an Oration Test will be taken where candidates will be required to speak spontaneously in Hindi / English for 3 minutes on any one of the 7 topics of current affairs or general interest given to them on the spot;

(3) Those clearing the Oration Test will be called for the first Simultaneous Interpretation Test (SIT) in selected language(s).

(4) An assignment shall comprise simultaneous interpretation of the speech as well as translation thereof in Hindi/English. Selected interpreter would be traveling in India and foreign countries as and when required.

(5) Candidates selected after the 1st SIT (Simultaneous Interpretation Test) will be imparted training.

(6) Empanelment as Interpreter of the concerned language will be done after passing of the second SIT to be conducted after the end of the training.

**Remuneration**: The remuneration shall be decided based on the qualification and experience of the candidate.
