#### A. SCOPE OF WORK

- a. To Select a Consultant for preparation of Detailed Project Report (DPR) for establishment of a National Institute and a Hunar Hub at Village Khohra Peepli, Tehsil Kishangarh Bas, District Alwar, Rajasthan.
- b. To Prepare Bid Document for tendering and to select contractors for construction of buildings and other structures as recommended in DPR by the Consultant and approved by MAEF, to supervise the construction works during the period of construction and to monitor the physical progress of the project including quality of works from time to time.
